THROUGH THE NEIGHBORHOOD REVITALIZATION PROGRAM, WE ALSO PROVIDE CRITICAL EXTERIOR REPAIRS TO QUALIFYING HOMEOWNERS. THESE APPLICANTS GO THROUGH A SCREENING PROCESS AND PARTICIPATE IN BUILDING OR REPAIRING THEIR HOME.
